The United Nations Convention on the Rights of the Child enshrines children and young people's rights to be protected from sexual abuse and exploitation. All children and young people are potentially at risk of being sexually abused. Schools have a central role to play in reducing this risk. By exploring the features of safe and healthy relationships, officers can help learners to develop the skills to identify potential risks, stay safe and seek help if needed.

The sexual consent lesson plan should be delivered as part of the school's PSE and sex and relationship education (SRE) programme. It should be consistent with the school's sex education policy and the agreed values framework for SRE. Discuss with the teacher that the lesson is appropriate for the needs of learners in terms of their age, maturity, language/images used, and understanding required. Furthermore this lesson is <u>only</u> to be delivered if a teacher is present in the classroom at all times.
